CONTRACTUAL RELATIONSHIP

The privacy policy, hereafter "policy", governs the policy policy in regard to the use of the website, hereafter "website", made available by Eva Global Corp., hereinafter "Eva", a joint stock corporation with limited liability under Canadian law, whose head office is located at 24 Mont-Royal Avenue West, Office 900.1, Montreal, Quebec, Canada, H2T 2S2, registered with Innovation, Science and Economic Development Canada, under the Canada Business Corporations Act (LRC 1985, Chapter C-44), under number of incorporation 1127387-6.

GENERAL

This policy is designed to assist you with understanding how Eva collects, uses and discloses the information you provide us when accessing or using the website, the mobile app, and any other product of Eva.

CHANGES

Eva may change this Policy in Eva sole discretion at any time. Any revisions to this Policy will be posted on the website. It is your obligation to periodically visit the website to review any changes that may be made to this policy. Your continued use of our website constitutes your agreement to be bound by any such changes to this policy. If you do not agree with this policy, you are not authorized to use the website and your sole recourse is to not use the website.

PAYMENT INFORMATION

Eva uses Stripe and Flutterwave as a third-party payment provider which requires information about your phone number and apps installed on your

device in order to ensure secure and successful payment. Eva does not collect any financial information. Stripe and Flutterwave collect your first name, last name, card number, card verification code, expiration date, card fingerprint, postal code, and more. Stripe and Flutterwave also collect and processes other personal data, including identifying information about the devices that connect to its services.

1. Stripe

Stripe provides end user services where it does not act as a service provider to Eva but instead provide the services directly to you for your personal use. See here for further information on the legal bases which Stripe relies on for using and processing your personal data.

Stripe uses or connects to your bank account. Stripe offers you the opportunity to store your payment methods with Stripe so that you can conveniently use it across merchants like Eva. When you opt in to link, you agree to let Stripe store your payment method so that you can more readily make purchases through link with Eva of our payment processing with you card number, card verification code, and expiration date.

If you choose to share bank account information with Stripe, Stripe will periodically collect and process your bank account information such account owner information, account balances, account number and details, account transactions, and in some cases, credentials, until you ask Stripe to disconnect your bank account.

COLLECTED INFORMATION

When you visit the website, you may provide Eva with two types of information: personal information that you voluntarily disclose that is collected on an individual basis; and information collected automatically when you use the website or the services available on the website, hereinafter "information".

Eva uses contacts in order to process referrals and reward the involved parties. Eva asks for permission before syncing any contact. The contacts are stored on Eva's private database to finalize the referral, and are never shared to any third party. Eva only needs the phone number for this to work and store no other data about the contacts.

When there is a referral, whether by phone number and/or email, Eva reserves the right to keep this personal information for tracking and updating purposes.

1. PERSONAL INFORMATION

Personal information is collected only when voluntarily offered and solely for purposes that are clearly identified on the website. Personal information means any information that is unique to you, as the following examples.

- a. First name;
- b. Middle name;
- c. Last name;
- d. Preferred name;
- e. Username;
- f. Password;
- g. Phone number;
- h. Email address;
- i. Internet protocol address;
- j. Location data;
- k. Mailing address, and;
- l. Other personal information you choose to provide.

By providing Eva with your personal information, you also consent for Eva to collect, hold, use and disclose your personal information in accordance with this policy. In addition to providing the foregoing information, if you choose to correspond further with Eva through email or through the contact section of the website, Eva may retain, use and disclose the content of your messages together with your email address and our responses.

2. AUTOMATICALLY COLLECTED INFORMATION

When you use the website or services available on the website, Eva automatically collect information from your devices. Eva collects the following information.

- a. Server log information: Eva collects server log information when you use the website, which may include, but is not limited to, your login details, the date and time of visits, the pages viewed, your Internet protocol address, time spent at the website and the websites you visit just before and just after the website;
- b. Device information: Eva collects information about the computer or mobile device you use to access the website, including the hardware model, operating system and version, the web browser you use, and other device identifiers;
- c. Telemetry information. If you use any of Eva's open source software, Eva may collect bandwidth upload and download speeds, the

amount of free and used storage space on your device and other statistics about your device;

- d. Usage information. If you use the website, Eva will collect metadata about the files you upload for storage and we will record instances in which you have used your private key to authenticate communications, and;
- e. Information collected by cookies and other tracking technologies: Eva and its service providers use various technologies to collect information when you interact with the website, including cookies and web beacons. Cookies are small data files that are stored on your device when you visit a website, which enable Eva to collect information about your device identifiers, Internet protocol address, web browsers used to access the website, pages or features viewed, time spent on pages, mobile application performance and links clicked. Web beacons are graphic images that are placed on a website or in an email that is used to monitor the behaviour of the user visiting the website or sending the email. They are often used in combination with cookies.

3. USE OF INFORMATION

Eva will only use the information for the following purposes.

- a. Providing, maintaining, delivering or improving the website or the products or services provided through the website;
- b. Analyzing and tracking data to determine the usefulness or popularity of certain content and to better understand the online activity of the website users;
- c. Fulfilling legal or regulatory requirements;
- d. Providing you with the information or products or services that you have requested;
- e. Answering your inquiry or responding to a communication from you;
- f. Developing new products or services;
- g. Sending you technical notices, support or administrative notifications;
- h. Communicating with you about news, products, services, events and other information Eva thinks will be of interest to you;

- i. Matching your information with job vacancies to assist Eva in finding a position that is most suitable for you if you have contacted Eva about recruitment;
- j. Monitoring and analyzing trends, usage and activities in connection with the website;
- k. Detecting, investigating and preventing fraudulent transactions or unauthorized or illegal activities;
- l. Protecting the rights and property of the Eva parties and others;
- m. Linking, connecting or combining information Eva collects from or about you with other Information, and;
- n. Carrying out any other purpose or reason for which the information was collected.

4. SHARING OF INFORMATION

Eva will only share Information about you in the following ways.

- a. With your consent or at your instruction;
- b. With the current or future parent companies, affiliates, subsidiaries and with other companies under common control or ownership with Eva or its offices globally;
- c. With third parties or service providers that perform work for Eva;
- d. Certain information you may choose to share may be displayed publicly, such as your username and any content you post when you use interactive areas of the website like Eva online forums;
- e. In connection with a merger or sale of our company assets, or if Eva does a financing or is involved in an acquisition or any other situation where Information may be disclosed or transferred as one of our business assets;
- f. In response to a request for information if Eva believes disclosure is in accordance with, or required by, any applicable law, regulation or legal process;
- g. If Eva believes your actions are inconsistent with our user agreements or policies, or to protect the rights, property and safety of any Eva party or others, and;

- h. With third parties where aggregate Information is disclosed which cannot be reasonably be used to identify you.

SOCIAL SHARING FEATURES

The website may offer social sharing features, links to social media and other integrated tools. Your use of such features enables the sharing of information with your contacts or the public, depending on the settings you use with the entity that provides the social sharing feature or social media. Please visit the privacy policies of the entities that provide these features to obtain more information about the purpose and scope of data collection and the processing of such data by such entities.

PROTECTION OF PERSONAL INFORMATION

Eva takes reasonable steps to protect the security of the information communicated through the website. However, no computer security system is entirely foolproof and the Internet is not a secure method of transmitting information. As a result, Eva does not assume any responsibility for the data you submit to or receive from Eva through the Internet or for any unauthorised access or use of that information and Eva cannot and does not guarantee that information communicated by you to Eva or sent to you by Eva will be received or that it will not be altered before or after its transmission to Eva. You agree to not hold Eva and its respective past, present and future third party providers, managers, users, members, volunteers, employees, officers, directors, contractors, consultants, suppliers, vendors, service providers, parent companies, subsidiaries, affiliates, agents, representatives, predecessors, successors and assigns, hereinafter "Eva parties", liable for any loss or damage of any sort incurred as a result of any misappropriation, interception, modification, deletion, destruction or use of information provided through the website.

Most web browsers are set to accept cookies as a default. You may wish to opt out by turning off cookies, please refer to the help menu on your browser; however, switching off cookies may restrict your use of the website.

You may also opt out of receiving promotional communications from us at any time by following the instructions in those communications. If you opt out, Eva may still send you non-promotional communications, such as technical notices, support or administrative notifications or information about your account, if you have one.
